Renter acknowledges that the Rental Vehicle has been made available for inspection before taking possession and accepts the vehicle in its condition at the time of pickup, except for damage specifically documented on the Vehicle Condition Report or otherwise documented by the Parties.

Renter may not extend the rental period without receiving prior approval from Carolina Drive Rentals.

4. RENTAL RATE AND PAYMENT

Renter authorizes Carolina Drive Rentals to charge the payment method provided by Renter for authorized rental charges, including, where permitted by applicable law: rental charges; approved extensions; late-return charges; fuel charges; cleaning charges; smoking-related charges; tolls; parking and traffic charges; towing and storage charges; damage charges; missing keys or key fobs; and other charges expressly authorized by this Agreement.

5. MILEAGE

Mileage Included: **UNLIMITED**

Unlimited mileage is included in the rental rate. Renter may operate the Rental Vehicle without a mileage limit during the rental period, subject to all other terms of this Agreement.

The vehicle's mileage will be recorded at pickup and return for maintenance, condition documentation, and fleet-management purposes.

6. SECURITY DEPOSIT

Renter shall provide a security deposit of: \$_____ ("Security Deposit").

The security deposit is intended to secure Renter's obligations under this Agreement.

The security deposit may be applied toward amounts lawfully owed by Renter, including documented damage, excessive cleaning, missing equipment, unpaid rental charges, fuel charges, towing, storage, or other amounts permitted under this Agreement.

The security deposit is not automatically forfeited merely because a violation occurs. Any amount retained will correspond to amounts actually owed or otherwise permitted by applicable law.

Any remaining security deposit balance will be returned according to Carolina Drive Rentals' stated deposit-return procedure and applicable law.

7. AUTHORIZED DRIVERS

No person may operate the Rental Vehicle unless they have been approved by Carolina Drive Rentals and meet all applicable licensing, age, insurance, and other requirements.

Renter remains responsible for the Rental Vehicle and for the actions of any person whom Renter permits to operate it.

Renter may not lend, sublease, rent, transfer, or otherwise provide possession of the Rental Vehicle to another person without prior written authorization from Carolina Drive Rentals.

8. DRIVER REQUIREMENTS

Renter represents that:

1. Renter possesses a valid driver's license;
2. Renter is legally permitted to operate a motor vehicle;
3. Renter's driver's license is not suspended, revoked, canceled, or otherwise invalid;
4. All information provided to Carolina Drive Rentals is truthful and accurate; and
5. Renter will immediately notify Carolina Drive Rentals if Renter's license, insurance, or legal ability to operate the vehicle changes.

Carolina Drive Rentals may verify Renter's identity, driver's license, insurance, and other information reasonably necessary to determine eligibility for the rental.

9. RETURN OF VEHICLE

Renter must return the vehicle to us in substantially the same condition as received, ordinary wear and tear excepted.

If Renter wishes to extend the rental, Renter must contact Carolina Drive Rentals before the scheduled return time. An extension is not valid unless approved by Carolina Drive Rentals.

Unauthorized late returns may result in additional rental charges and other reasonable costs permitted by applicable law.

10. VEHICLE RECOVERY

To the extent permitted by applicable law, Carolina Drive Rentals may seek to recover the Rental Vehicle if the rental period has expired, required payment has not been made, the vehicle is being used in violation of this Agreement, the vehicle has been abandoned, required insurance is no longer valid, Renter provided materially false information, or Carolina Drive Rentals otherwise has a lawful basis to recover the vehicle.

Carolina Drive Rentals will not use self-help recovery methods prohibited by applicable law.

Renter may be responsible for reasonable recovery, towing, and storage costs for which Renter is legally responsible.

11. DAMAGE TO OR LOSS OF THE VEHICLE

If the vehicle is lost, stolen, or damaged during the rental period, Renter is responsible, to the extent permitted by applicable law and subject to applicable insurance coverage, for loss or damage caused by Renter, an authorized driver, or another person to whom Renter provided possession or access.

Renter must promptly report any damage, loss, theft, vandalism, accident, or mechanical problem to Carolina Drive Rentals and cooperate with any investigation.

Where permitted by law, Renter may be responsible for reasonable repair or replacement costs, towing, storage, loss of

use, and other directly related expenses for which Renter is legally responsible.

Renter may not repair or arrange repairs without prior written authorization from Carolina Drive Rentals, except when emergency action is reasonably necessary to protect persons or prevent additional damage.

12. PROHIBITED USE OF THE VEHICLE

The Rental Vehicle may not be:

- A. Operated by an unauthorized driver;
- B. Used to carry passengers or property for hire unless expressly authorized;
- C. Used to tow or push anything unless authorized;
- D. Used in a test, race, contest, drifting event, or similar activity;
- E. Operated while the driver is under the influence of alcohol, drugs, or another impairing substance;
- F. Used for any illegal activity;
- G. Used to transport illegal drugs, contraband, or stolen property;
- H. Operated recklessly or overloaded;
- I. Taken outside the United States without prior written authorization;
- J. Used for rideshare, delivery, courier, or other commercial purposes unless expressly authorized;
- K. Used in violation of applicable law or the applicable insurance coverage; or
- L. Used in a manner that intentionally or recklessly damages the vehicle.

Renter must promptly report accidents or damage and cooperate with Carolina Drive Rentals and law enforcement when required.

13. FUEL

Fuel Level at Pickup: _____

Renter must return the vehicle with approximately the same fuel level unless otherwise agreed in writing.

If the vehicle is returned with less fuel than required, Renter may be charged the reasonable cost of replacing the missing fuel plus any disclosed service charge.

Renter must use the correct fuel for the vehicle.

14. SECURITY DEPOSIT

The Security Deposit amount is stated in Section 6.

The deposit may be applied to documented amounts properly owed under this Agreement. Smoking, excessive cleaning, damage, missing keys, late return charges, or other permitted charges may result in a deduction from the deposit.

Renter remains responsible for amounts exceeding the deposit, to the extent permitted by applicable law.

15. PROPERTY IN THE VEHICLE

Carolina Drive Rentals is not responsible for loss, theft, or damage to personal property left in or on the Rental Vehicle.

Renter is responsible for removing all personal property before returning the vehicle.

16. INSURANCE

Before taking possession of the Rental Vehicle, Renter must provide proof of insurance acceptable to Carolina Drive Rentals and applicable to the Rental Vehicle and Renter's intended use.

Renter is responsible for maintaining all insurance required by law and by this Agreement throughout the entire rental period.

Renter must immediately notify Carolina Drive Rentals of any cancellation, expiration, suspension, or material change to the insurance coverage provided.

Renter is responsible for any deductible, uninsured amount, excluded loss, or other amount for which Renter is legally responsible under the applicable insurance policy and this Agreement.

Providing proof of insurance does not eliminate Renter's contractual obligations under this Agreement.

17. INDEMNIFICATION

To the extent permitted by applicable law, Renter agrees to be responsible for claims, losses, damages, fines, penalties, and reasonable expenses arising from Renter's unauthorized, negligent, reckless, or unlawful use of the Rental Vehicle.

Nothing in this Agreement is intended to eliminate any liability or protection that cannot legally be waived.

18. COLLECTIONS

If Renter fails to pay an amount properly due under this Agreement, Carolina Drive Rentals may pursue collection through lawful means.

To the extent permitted by applicable law, Renter may also be responsible for reasonable collection costs, court costs, and attorney fees arising from Renter's breach of this Agreement.

19. REPRESENTATIONS AND WARRANTIES

Owner represents that, to Owner's knowledge, the Rental Vehicle is in reasonably good condition and safe for ordinary operation at the beginning of the rental.

Renter represents that Renter is legally entitled to operate a motor vehicle and will not operate the vehicle in violation of applicable law.

Renter acknowledges having an opportunity to inspect the Rental Vehicle and agrees that existing damage will be documented by the Vehicle Condition Report and/or photographs.

20. ENTIRE AGREEMENT

This Vehicle Rental Agreement, together with any Vehicle Condition Report, reservation terms, payment authorization, insurance documentation, and other documents incorporated into the rental transaction, constitutes the agreement between the Parties concerning the rental.

Any amendment must be made in writing or through another legally valid electronic method agreed upon by the Parties.

Cancellation and refund terms will be disclosed to Renter before or at the time of reservation. Nothing in this Agreement is intended to waive any consumer right that cannot legally be waived.

21. GPS / VEHICLE TELEMATICS

The Rental Vehicle may contain manufacturer-installed or other GPS, telematics, location, mileage, diagnostic, or vehicle-management technology.

To the extent permitted by applicable law, such technology may be used for vehicle location, theft recovery, mileage verification, maintenance, diagnostics, safety, fleet management, and enforcement of this Agreement.

Renter may not disable, remove, tamper with, or interfere with any tracking or vehicle-management equipment.

22. MAINTENANCE AND MECHANICAL PROBLEMS

Renter must promptly notify Carolina Drive Rentals of warning lights, mechanical problems, unusual noises, or other conditions affecting the safe operation of the vehicle.

Renter must not continue operating the vehicle when doing so could reasonably cause additional damage or create an unsafe condition.

Routine maintenance and mechanical issues caused by normal wear and not caused by Renter remain the responsibility of the Owner, subject to applicable law.

Damage resulting from misuse, neglect, unauthorized modifications, or continued operation after a warning may be charged to Renter to the extent permitted by law.

23. GOVERNING LAW

This Agreement will be governed by applicable law, subject to any mandatory federal, state, or local laws applicable to the rental transaction.

24. SEVERABILITY

If any provision of this Agreement is determined to be invalid or unenforceable, the remaining provisions will remain in effect to the extent permitted by law.

25. ELECTRONIC SIGNATURES

Electronic signatures, electronic records, and electronically delivered copies of this Agreement may be used and will have the same effect as handwritten signatures to the extent permitted by applicable law.

Renter acknowledges that Renter has had an opportunity to read this Agreement and ask questions before signing.

26. RENTER ACKNOWLEDGMENT

By signing below, Renter acknowledges that:

- Renter has read and understands this Agreement;
- Renter has provided truthful information;
- Renter has inspected the Rental Vehicle or had an opportunity to do so;
- Renter understands the rental rate and security deposit;
- Renter understands that mileage is unlimited;
- Renter understands the insurance requirements;
- Renter understands the prohibited uses;
- Renter understands that only authorized drivers may operate the vehicle; and
- Renter agrees to return the Rental Vehicle as required and to satisfy obligations imposed by this Agreement to the extent permitted by applicable law.
